**JOB SUMMARY:** Performs various tasks to construct and maintain high voltage electrical equipment and apparatus. Responds to electrical emergency situations.

**JOB DUTIES AND ACCOUNTABILITIES:**

Climbs ladders, poles, steel structures, in and out of ditches, on and off equipment, often times in close proximity to high voltage lines. Understands electrical high voltage clearances to perform work safely and follows all safety procedures in establishing appropriate working clearances, or hot work.	60
E	2. Operates various equipment such as a digger derrick, aerial lift device, trencher, backhoe, crane, etc. as well as loads and unloads trucks and trailers for transporting electrical equipment.	20
E	3. Drives single or combination vehicles 26,001 or more lbs.	5
E	4. Inspects tools and equipment for wear or defects to assure safe and proper operation.	5

**EQUIPMENT, AIDS, AND TOOLS:**

Electrical testing equipment and various detection devices (voltmeters, phase sequence indicators, air samplers, locating devices, etc.); heavy construction equipment (backhoe, trencher, crane, digger derrick, aerial lift device, etc.); electric hand tools and gas powered tools (drills, saws, tamps, etc.); various pneumatic and hydraulic tools (boring equipment, jack hammers, drills, saws, tamps, etc.); and a vehicle that requires a CDL Class A license.

Maintenance Supervisor, Job Foreman, Lineman, Lineman Apprentice, Operations personnel, storeroom personnel, and the general public.

**WORKING CONDITIONS:**

Work is performed outdoors in all types of weather, day or night.

Work is performed below ground, above ground, in high places, and within confined spaces near energized electrical equipment.

**KNOWLEDGE, SKILLS, AND ABILITIES:**

Knowledge of high voltage electrical standards, procedures, clearance, and working regulations.

Mechanical skills to construct and maintain various electrical apparatus.

**PHYSICAL REQUIREMENTS:**

Ability to climb and stand or stoop at high elevations or stoop, kneel or crouch while constructing and maintaining electrical equipment for extended periods of time (3-4 hours).

Ability to work outdoors in all types of weather, day or night.

Ability to lift in excess of 100 pounds occasionally or 50 pounds frequently.

Ability to push, pull, lift, reach on regular basis.

Ability to grasp heavy construction tools but also perform precise intricate work.

Ability to use independent judgment under ideal and emergency conditions.

Must have unrestricted 20/20 eyesight (corrected 20/20 is accepted). Colorblindness is unaccepted.

**TRAINING AND EXPERIENCE/MENTAL REQUIREMENTS:**

Requires knowledge, skill and mental development equivalent to completion of four years of high school and must have completed an approved 4-year Lineman Apprenticeship or education equivalent; experience in constructing and maintaining electrical equipment; and training in the operation of heavy equipment such as a digger derrick, aerial lift device, backhoe, trencher, crane, etc.

**ADDITIONAL REQUIREMENTS:**

Possession of a valid CDL Class A driver's license.

Must have the ability to wear fire retardant clothing and protective gear.

Ability to acquire additional training (C.P.R., First Aid, asbestos, etc.).

A.	<b>CLIMBING:</b> Ascending or descending ladders, stairs, scaffolding, ramps, poles, etc., using feet and legs and/or hands and arms. Body agility is emphasized. Important if the amount and kind of climbing exceeds that required for ordinary locomotion.	1,2,3	15
